## 7.2. COVID 19 Update (Presenter – Barry Gallison, VP Risk and Quality Management)

Mr. Gallison gave a summary of the year-over-year status of CLABSI, CAUTI, and CDIIF infections.

Vaccinations: 72,106 vaccinations given by Broward Health as of March 23, 2021, including 9,695 employees. Approximately 1,800 vaccinations are being given per day at the present time.

## 7.3. ORO 2.0 Software Assessments (Presenter – Barry Gallison, VP Risk and Quality Management)

Mr. Gallison clarified that the survey is a 52-question test taken individually by staff. The data is aggregated on a scale, reporting the progress to leadership.

- High-Reliable Organizations
  - It was noted that the culture of safety survey is currently in progress.
  - Three main domains:
    - Leadership.
    - Safety culture.
    - Robust process improvement.
  - Mr. Gallison gave a brief overview of the ORO 2.0 Executive Summary for each of the four Broward Health hospitals.
  - Mr. Gallison made reference that the surveys help with strategic planning.
