

Automatic Enrollment Internal Talking Points for Opting out


Broward Health is committed to helping you take action towards a more secure retirement. Automatic enrollment in your tax-advantaged retirement plan represents our latest plan enhancement to help you plan for and live a robust retirement.

All new employees will be automatically enrolled in the retirement plan at 2% contribution percentage of compensation. New hires have 45 days to opt out of enrollment.

Existing employees who no longer wish to make contributions may log into their account and set their contribution rate to zero. Once logged in, select **manage contribution** under the 'Manage' dropdown menu at top of account page and follow the prompts.
